pre-registering on-line using REACH-IT



- before pre-registering
 - the company has signed up to REACH-IT
 - a company user needs to be logged in
 - the company user needs to have the information on the substance he wants to pre-register at hand
- selects “pre-register a phase-in substance” in the functional menu

pre-registering on-line using REACH-IT

- A wizard take the user through a number of steps (implemented as different tabs)
 0. declaration on “phase-in” status will be added (mandatory)
 1. **identification:** mandatory
 2. **similar substances:** optional
 3. **tonnage/date:** mandatory
 4. **contact:** optional
 5. **representative:** optional
 6. **remarks:** optional
 7. **validation:** mandatory

typically takes 2 – 40 minutes to go through all steps

1. identification: type in the name of the substance you want to pre-register

For a (mono-constituent) substance that has an EC n°:

- the company user specifies :
 - the EC number, or the EC name, or
 - the CAS number, or
 - the molecular formula.
- REACH-IT retrieves the substance from the EC inventory.
- the company user confirms / selects from the presented options the substance he wants to pre-register.
- no additional chemical names can be entered.

pre-registering on-line using REACH-IT



1. identification:

For a (mono-constituent) substance that DOES NOT have an EC n°:

- the company user specifies:
 - CAS number and name(s), or the chemical name(s).
- REACH-IT then checks
 - the EC inventory
 - all the previously pre-registered substances
- if REACH-IT finds a match, the company user confirms whether or not (one of) the presented option(s) is the substance he wants to pre-register.
- additional chemical names can be entered.

pre-registering on-line using REACH-IT



1. Identification:

For a multi-constituent substance:

- the company user enters the name of the first constituent as if it were a mono-constituent substance,
- then he clicks “add more constituents” until he has entered all constituents (max.10) of the substance he wants to pre-register.

pre-registering on-line using REACH-IT



1. Identification: type in the name of the substance you want to pre-register

- wild card symbol * can be used, so there can be more than 1 match when retrieving a substance from the EC inventory.
- EC number and CAS number have to be entered in the correct format.
- check digit for CAS number is checked.

pre-registering on-line using REACH-IT



2. **Similar substances:** type in the names of the substances suggested for QSAR, grouping or read-across
 - using the same mechanism for identifying a substance as in “1. identification”
 - a large number of similar substances can be accommodated

4. Contact 3 possible scenarios:

pre-registering using the bulk upload

- After pre-registering
 - the company user will receive 1 submission number after validation.
 - REACH-IT will verify the file format, structure and content of the file. The submission is **rejected** if:
 - the file format or structure is not correct,
 - a substance is included without an EC n^o, or
 - a substance is included with an invalid EC n^o, or
 - the UUID of the TPR does not exist in REACH-IT.
 - the company user will receive a message in his internal mailbox, containing the result of this verification.
 - if the submission is rejected, the submission report will indicate where the problem was.

pre-registering using the bulk upload

- After pre-registering (cont'd)
 - if a substance is included in the file more than once, it is treated as an update for that substance.
 - when successfully pre-registered, the company user will receive a message in his internal mailbox, containing:
 - a link to the submission report (pdf format) and
 - the pre-registration numbers for the different substances pre-registered.
 - the company will have access to the pre-SIEF webpages (all users).
 - the company can view their pre-registrations by selecting “view pre-registrations” in the functional menu (all users).

pre-registering using the single upload

- combines elements of **on-line pre-registration** and **bulk upload**
 - the company needs to have prepared the file (using the IUCLID pre-registration plug-in or another application), but for only 1 substance.
 - a company user selects / confirms / submits the file.
 - if no EC n° is specified for the substance, REACH-IT checks the EC inventory and all the previously pre-registered substances.
 - the company user confirms whether or not (one of) the presented option(s) is the substance he wants to pre-register.

updating a pre-registration

- the submission of a subsequent pre-registration (during the pre-registration period) for a substance a company has already pre-registered is considered an update.
- a pre-registration can at any time be updated in REACH-IT, independently from the way it was submitted (on-line pre-registration, bulk or single upload).
- all fields can be updated, except the substance identity.
- the information in the pre-SIEF will be updated accordingly.
- a pre-registration cannot be deleted. If a potential registrant is no longer interested in a substance, he can deactivate his participation in the pre-SIEF, but he remains visible.

using a third party representative



- If a TPR has obtained a UUID from the IUCLID website, he should import this UUID in REACH-IT during his sign-up (as of June 1, 2008) to make his UUID known to REACH-IT.
- A TPR has to communicate his UUID to his clients so they can prepare their pre-registration.
- A TPR's UUID must be known to REACH-IT before his clients submit their pre-registration.
- A TPR will have access to the pre-SIEF webpages of the substances pre-registered by his clients.

pre-SIEF: creation

upon receipt of the 1st pre-registration for a substance:

- a pre-SIEF webpage is created for that substance
 - the company/TPR can view the pre-SIEF by selecting “view pre-SIEF” in the functional menu (all users).
 - the company/TPR is listed as a participant in the pre-SIEF.
- pre-SIEF webpages are created for each of the substances suggested for read-across
 - the company/TPR can “navigate” to these webpages.
- for multi-constituent substances, pre-SIEF webpages are created for the individual constituents
 - the company/TPR can “navigate” to these webpages.

pre-SIEF: participation

will be added to the existing pre-SIEF:

- Subsequent potential registrants
- Data holders signing in after publication of the list of pre-registered substances (01.01.2009)
- Registrants
 - submitting before 01.06.2018
 - of substances regarded as registered

pre-SIEF: SIEF formation facilitator

To initiate discussions after pre-registration a “SIEF formation facilitator” can be identified on the pre-SIEF webpage:

- Only potential registrants can volunteer to become SIEF formation facilitator, on a first-come first-serve basis.
- Not legally binding, no additional obligations.
- Can post information to the other participants in a separate text box on the pre-SIEF webpage, e.g. on further communication tools to be used.

- MSCA and ECHA can search for pre-SIEFs:
 - by substance, company, SIEF facilitator, ...
- ECHA will put together and publish on the internet the list of pre-registered substances by 1.1.2009 (art.28(4)).
